Background

- Current situation:
 - Several States with new firewood regulations and/or policies
 - Federal Order in place requiring heat treatment of imported Canadian firewood
 - No Federal commodity based regulation for interstate firewood movement, but it is a regulated article under some pest specific quarantines
- State-Federal recognition that a National Strategy is needed
 - NPB, NASF, USFS, and APHIS began current discussion in winter 2008
 - August 2009 National Plant Board meeting: Recommendation made that a Firewood Task Force be convened to develop recommendations for a national firewood strategy

National Firewood Task Force (NFTF)

- First convened in October
- 17 Members
 - 7 State (NPB: FL, IN, ME, OR; NASF: MI, VA, WY)
 - 1 USFS
 - 1 NPS
 - 7 APHIS
 - 1 Facilitator
- Goal: To develop recommendations outlining the key elements of a National strategy to prevent the movement of invasive forest pests in firewood.
 - Recommendations will address three main areas:
 - Regulatory: The potential for Federal and/or State treatment requirements
 - Voluntary: Industry led efforts to develop a “gold standard” or similar
 - Outreach: Develop messages for producer, distributor and user groups and identify how to communicate them

NFTF Timeline

- Fall 2009
 - Task Force Formed
 - Subgroups on Regulatory, Outreach and Voluntary measures identify opportunities for Partner/Stakeholder input
 - Subgroups develop preliminary recommendations and dialog with Partners and Stakeholders on what the key elements of a national strategy should look like
- January-February 2010
 - Subgroups refine recommendations
 - Task Force meets to combine subgroup recommendations into a master document
 - Master document finalized in late winter
- March-April 2010
 - Final document shared with NASDA, NPB, NASF and posted online.

Current Activities

- Subgroups meeting weekly to develop recommendations
- Task Force expected to meet in mid-January to begin merging the three subgroup white papers.
